with Mr. J. C. Price, the engineer in charge of the building.

- Q. Mr. Price, did you work at this building on November 22nd, 1963?
- A. Yes sir, I did.
- Q. And where were you at the time that the Presidential motorcade drove through Dealey Plaza? I'd A. Well, I went up to the roof and - uh - where ixeaulax get a better view of the caravan, and - uh - I watched 'em, of course, turn right off of Main, left onto Elm and uh - I -I'd seen Governor Connally slump and - uh - of course I didn't - I wasn't watchin' the President, but he probably slumped firest. And - uh - I saw - saw them both fall all right. But President Kennedy raised up and leaned forward, and his wife got him by the arm and pulled him back down. And - uh - well, at that time there was a Civil Service man - Secret Service agent trying to get on to the back of the car, and Mrs. Kennedy reached over and leaned back and caught his arm and pulled him on the car and then it went out of my sight under the Underpass.
- Q. Mr. Price, did you hear any whots?
- A. Yes, I heard five shots. I counted them, and I think

 in about two seconds, two more from the same gun and they

- Q. Were you ever called as a witness by the Warren Commission?

 A. No sir, I wasn't.

Q. Did you see anything after the shots were fired?

A. Yes, I saw a man running from the overpass. I paid particular attention to him. I think I can describe his clothing - the way he was dressed - he was in khaki trousers. A man carrying about 1h5 pounds of weight and not too tall; I'd say 5'6" or ER 7". He was bare-headed, and - uh - he was running very fast, which give me the suspicion that - that he was doing the shooting, but I could be mistaken, and - uh -he had something in his hand. It could have been a head-piece; it could have been a gun; it could have been most anything because I couldn't see that well enough to detect. And he ran behind the wooden fence on around till I lost sight of him behind the

Q. Did you tell that to the Dallas Sheriff's office on November 22nd?

A. I sure did.
