And I asked him where he had thrown it. And - uh - he told me 'at - uh - had thrown(it) in the waste-basket. So we all went looking for it-uhtwo or three salesmen and myself. We wanted the prospect card. We never could find the card at any time. So the Commission showed me some pictures of Oswald, and em whether wanted me to - uh -uh - tell/if this was the man that came to the showroom or not. The only-uh-uh - the only time I had any connection with this party, was Mr. Bogard brought a man to my office door -uh - and asked me how much money down he would need to buy a car. And when I found out the man had no credit, I told him he would need 2 two to three hundred dollars. Mr. Bogard said "Well he will have in two or three weeks". And that was around fifteen seconds. That was all there was to it, and - uh - they walked off back in the booth. Q. How long before the assassination did that take place? A. Uh - about a couple of weeks, I'd say. I - I could be

wrong in the exact date, but I think it was around two me two and a half weeks before -

Q. Mr. Pizzo did the Commission show you pictures of Lee Harvey Oswald?

A. Yes, they did.

Q. Did you identify the man in the picture as the man who

had come into your automobile salesroom?

A. Well in a-a- I made a point about the hairline, which is the only thing/I remember about the man he had a receding -uh- forehead and - uh - uh - sort of a widow's peak, but kinda weak, man - uh - in other words, he was - uh - I think he was losing his hair. Now the man had a T-shirt and he was around five feet seven, five feet eight. But I-I only saw him for fifteen seconds and it resembled this Oswald. I couldn't say for sure whether it was him or not, at the time. But the incident that the salesman called to my attention -uh - later in the day-uh-I remembered that incident that evenings uh - that this man came to my office and he brought the - Now the pictures I picked out - uh - some of them looked like him, and some didn't. So I wasn't positive whether - uh - these pictures was the same man.

Q. Did he look like the same man?

A. Ah - well, in a way he did. In certain pictures he looked like the same man.

Q. Do you know where Mr. Bogard is?

A. Yes, he did. Wih - he had shown me - we call 'em - work-sheet on him, and - uh - he said that he would poss-

ibly be out, and if I wanted worked this customer around, would take the commission, we'd split it in half. At that time, I mean like I said it about his jotting card "Lee Oswald" down on the firmer and what type of car he was interested in. I have not been able to find the card since, but I actually was never introduced to the man.
