Did you tell the Warren Commission precisely what you've just told me about your encounter with Jack Ruby at the Parkland Hospital? Did you have occasion to talk with Eva Grant about what you observed at the Parkland Hospital? What did you tell her? Did you receive any other telephone calls before that? Between the time that you received the letter from the Commission, inviting you to testify, and the time that you received a telephone call later that day, advising you that it would be best for you to remain silent, had you told anyone that you had been invited to testify before the Commission? Did you recognize the boice of the man who called you? To your knowledge, did the Warren Commission ever investigate the telephone calls that you received and the barricading of your door early one morning? When did you receive the letlet inviting you to testify before the Warren Commission? When did you receive the letter inviting you to testify

before the Warren Commission, and when did you receive the phone call, advising you to remain silent? Did you have a direct and unobstructed view of Jack Ruby? (Repeat) Did you have a direct and uno -- Did you have a direct and unobstructed view of Jack Ruby for approximately three minutes while he was engaged in a conversation with another man? Did you tell the Warren Commission that you were standing just three feet from Jack Ruby, that you had an unobstructed view of Jack Ruby, and that you observed him involved in a conversation for approximately three minutes? Do you recall what day it was that you received the letter inviting you to testify before the Warren Commission? On about that day, did any unusual occurrences take place about your home? What was the nature of the telephone call? Did you answer the door? What time of the night was that? Was it past midnight? Did you tell Eva Grant that you had seen her brother at the hospital? Did you tell Eve Grant that you saw Jack Ruby at the Parkland Hospital? What did Eva Grant reply? Did you - did you ever have an opportunity to view the clothing that Jack Ruby wore on November 22? Did you see the hat or the coat again? Do you believe that the man you saw at the Parkland Hospital was, in fact, Jack Ruby? Do you know that Seth Kantor, a well-known and respected Scripps-Howard reporter testified that he knew Jack Ruby over a period of years and that he saw Jack Ruby at the

Parkland Hospital on November 22nd? At approximately what time of the day did you see the genelemen at the Parkland Hospital who you believe was Jack Ruby? How long does it take to drive from the Parkland Hospital to your home? Was your husband at home when you received the telephone call? Who do you think it was that was calling? Mrs. Tice, what time of the night was it when the telephone began to ring, the doorbell began to ring, and you discovered that both the front and back doors were barricaded?

I'll tell you (Mrs. Tice: Hey,/I know what day it was that I saw the coat over at Eva Grant's.

Q. Oh, when was it?

A. It was the day I went before the Warren Commission, after I came back from there.

Q. Mrs. Tice, at the time that you testified before the Commission and told the Commission that you saw Jack Ruby at the hospital, had you known that Seth Kantor, a Scripps Howard reporter, had also told the Commission that he saw Jack Ruby at the hospital?

Q. Do you recall what day it was when Eva Grant showed you the jacket that you saw Jack Ruby wearing

A. While I was at Parkland Hospital all the people

WERR were milling around, and at this time I saw this man that I believed was Jack Ruby. He was standing there - uh - looking toward the Parkland entrance and I walked down closer - I was about three feet away from him, and there was a man that came along and got behind Jack, this Jack that was out here and slapped him on the shoulder/ask(ed) him how he was doing, and then he turned around and started talking to this man and that's how I that's when I saw Jack Ruby, the one and - well I don't know how to tell you this about the - uh when I heard that he had, when I heard that he had shot - uh - Oswald, I couldn't understand why that he was out at Parkland Hospital and he was wanting - he told this other man when they ask him what was wrong with Connally, well, they said that he had been shot in the kidney or something, and uh - Jack said "Can't they give him another kidney? or "Can't anybody do anything about it?" and this man said something about givin' him a kidney but Jack said - er - this man asked Jack, "Well, who in the hell is going to give him a kidney?" and Jack said, "Well, I will". And the other man went on, and Jack went on toward the front of the emergency remm entrance, and I looked at my watch and that's when I knew that I had to go home because my children were going to be gettin' home from school.

Q. Did you have an opportunity to speak with Jack Ruby's sister, Eva Grant regarding Ruby's presence at the Parkland Hospital.

A. Yes, I did.

Q. And would you tell us - uh - how that came about, and what you said to Eva Grant and what she said to you.

A. You mean how it came that I - talked with Eva Grant to begin with?

Q. Yes, please.

A. Uh - well I didn't know her. Q. Did you know that Seth Kantor - a Scripps Howard reporter, testified before the Commission that he had known Ruby for some years, and that he encountered Ruby at the Parkland Hospital on November 22nd, and that he had a conversation with him? A. No. I didn't know anything about this at all, I mean I don't know this man, and I don't and I didn t know that he had said this. I had heard something about it - uh - once or twice. In fact, just the other day I heard that something about it. Well, when your lady was talking to me - and uh - well I just didn't know him, didn't know anything about it.

- Q. At what time of the day, would you say, that believe you saw this gentleman whom you think was Jack Ruby?
- A. I have no idea what time it was, except that

 I know that I was there at one o'clock, and I on know that I was back at my house ** Lakemount

 Drive at three o'clock.
- Q. And how long does it take to drive to your home from the Parkland Hospital?
- A. Well, it took me fifteen minutes that day because I knew that I got home in - that I got home at three o'clock and my children get there at ten after three.
- Q. So you saw Jack Ruby or his twin brother between one pm and 2:45 pm on November 22nd?
- A. That's about right.
- Q. And you had a direct view of him from a distance of three feet, and you observed him involved in con-

versation for approximately three minutes?

A. That's right.

Q. Well, under those circumstances, can you explain
this reference in the Warren Commission Report to
your testimony: "The only other person besides Kantor
who recalled seeing Ruby at the hospital did not make
known her observations until April 196h, had never seen
Ruby before, allegedly saw him only briefly then, had an
obstructed view and was uncertain of the time?

A. Well I didn't have an obstructed view, I don't know um - I guess I was nervous - uh - I know I was upset by
having to go up to the Warren Commission, and - uh - well,
I don't know why they thought that, because they had me
to draw 'em a picture.

-that I had told anyone that I had seen Ruby at the hospital - when I talked to Eva Grant....

Q. Mrs. Tice, when you testified before the Warren Commission, did you tell them that you were standing about three feet from Jack Ruby, that you were looking directly at him, and that you overheard a conversation in which he was involved for about three minutes?

A. Yes, I did.

- Q. Do you recall on which day you received a letter from the Commission inviting you to testify?
- A. I received a letter on a Sunday.
- Q. And on or about that day, did any unusual occurrences take place in your home.
- A. That day, no. It was that night that I received the telephone calls and uh somebody was tampering around the
 house uh pulling the latch on the front door and ringing
 the telephone and putting a ladder up against my back door,
 and we had quite a bit of commotion over that.
- Q. What was the nature of the telephone calls?
- A. The telephone call that I received that night was uh well they just hung up. And the doorbell rang right away after the telephone rang.
- Q. Did you answer the door?
- A. I went to the door and I and I said "Yes?" and nobody

answered, so I turned on the porch light and looked through the lattice-screen, and I saw no one there, so I started to open the door and look out, but the latch was turned on the other side. That's when I went to the other - well I was just walking the floor wondering what to do. I was rather upset about this because I didn't know what was takin' place, and I turned on my back porch light - the ladder was up against the door in the back. And so I called my husband home from work and right away he called the police.

- Q. What time of the night or day was that?
- A. I don't remember really but it was late late at night. I don't I don't really remember.
- Q. Was it past midnight?
- A. It seems like uh well I had been in bed; I had been asleep already -
- Q. Uh huh.
- A. So I don't remember now if it was around twelve or one or two .
- Q. Did you receive any other telephone calls during that period?
- A. Before that I received these telephone calls telling

 me uh to keep my mouth shut if I knew what was good

 for me to keep my mouth shut. No, I received this call

 after I got my letter from the Warren Commission.

Q. Telling you that you should keep your mouth shut?

A. Yes - if I knew what was good for me, to keep my mouth shut.

Q. Did you discuss with anyone the letter that you had received from the Commission inviting you to testify?

A. Uh - I had - no I didn't talk to anybody about this letter except when I talked to Eva because - uh - and then when I talked to her I thought she already knew - or, if this was Jack, I thought she knew he was out there and I thought the police and everybody knew, because I thought they knew where he was and every place he had been.

Q. Between the time that you received the letter from the Warren Commission on a Sunday inviting you to testify and the time that you received x the telephone call advising you that it would pay you to keep quiet, had you told anyone that you had been invited to testify before the Commission?

A. Let me think. No - uh - well I don't. Say that again,
Q. From the time that you received the letter inviting you
to testify before the Commission and from the time that
you received the phone calls advising you it would be best
for you to remain silent, had you told anyone that you
had been invited to testify?

A. Well, I hadn't talked to anybody about this at all ex-

cept when I talked to Eva. And then, when I went to

St. Louis, the FBI came up there and talked with me
uh - I was at my mother's home and right away I came

back to Dallas and - uh - then when this took place

that night with the police and the - uh - everybody

that came out to the house - reporters and - that's all.

Q. Did you recognize the voice of the man who told you

to remain silent?

- A. No, I had never heard this voice before. If I had I never I just didn't remember.
- Q. How would you say the episode that Sunday evening and the telephone calls affected you when you testified before the Commission, if at all?
- A. Well how it affected me? The phone call and this tampering around the doors and things?
- Q. Yes.
- A. Well it was upsetting and made me nervous, because I couldn't figure out what was goin' on, because I didn't think that I knew anything that could hurt anybedy as far as this Warren Report was... I just didn't know. Because I thought the police already knew everything that anybody else did or anything that I knew anyway.
- Q. To your knowledge did the Warren Commission ever investigate the telephone calls to your home or the tampering with your door?
- A. No, not that I know of. The Warren Commission didn't

even come out and talk to me, I mean other than when I testified up there.

Q. Mrs. Tice, when did you receive the letter from the Warren Commission inviting you to testify as a witness, and when did you receive the telephone call advising you to remain silent?

A. I received the letter from the Warren Commission
Sunday about moon, and Sunday afternoon - it must have
been about two and a half hours or three hours later
when I got the phone call - uh - advising me to keep
my mouth shut if I knew what was good for me, or someto
thing like that effect.

Q. And, between noon when you received the letter and 2:30, or approximately 2:30, when you received the phone call advising you to remain silent, had you told anyons that you had been invited to testify before the Commission?

A. Nobody knew that I had been invited except my husband came in when I got the letter, and he was right there with me all the time - uh - when I got the letter, my husband came home with the children from Sunday school and - he nobody - was right there in the house. So nobody knew/- I hadn't talked to nobody at all.

Q. Was your husband in the house when you received the

phone call?

A. Yes.

Q. Who do you think called you?

A. I have no idea. I can't figure it out - I mean, that's that's the one thing that's made me nervous because I mean
I couldn't figure out why. (background technical conversation) Then I had somebody else to answer the phone, because it just - why I'd go to answer the phone and then
to start
hang up. And then I'd go/to do something else, and the
phone would ring and I'd say, "Well, answer it," and they'd
answer - nobody at all.

(background technical talk)

Oh - I'd say four or five times I guess...they just ...
that I know of - that I paid any attention to, really.

Q. And then it was later that same evening when the door
.... the same evening you received the phone call?

A. That was late, though.

Q. About what time do you think it was?

A. That was late at night. I don't know - uh - I was trying to think. My husband goes to work at - uh - ten, and - uh - we went to bed after he went to work... Well, it must have been about two o'clock - one or two o'clock in the morning.

Q. One or two o'clock in the morning is what you teld the pelice, as a matter of fact.
